Individuals wanting to be certified as a CNA Instructor must be approved by the DHSS to attend the train-the-trainer course. This training course is conducted either by a Long-Term Care (LTC) Association or the Missouri Department of Elementary and Secondary Education. The applicant must meet the following qualifications to become an instructor:

An instructor shall be a registered professional nurse currently licensed in Missouri or shall have a temporary permit from the Missouri State Board of Nursing. The licensee shall not be subject of current disciplinary action, such as censure, probation, suspension or revocation. 2.
