High-alert medications - dosing limits, administration guidelines, packaging, labeling and storage. Availability of up-to-date medication information. Availability of pharmacy expertise.

Pharmacies must bill the specific national drug code (NDC) number for the drug dispensed in the amount dispensed and maintain invoices of drug purchases that document proof of purchase for quantities of specific drugs reimbursed by the Division. Pharmacies must reflect purchase dates consistent with dispensing dates.
