The Columbia River Treaty A

Signed in 1961, the Columbia River Treaty calls for two “entities” to be designated to implement arrangements under the Treaty — a U.S. Entity and a Canadian Entity. The U.S. Entity, designated by the President , consists of the Administrator of the Bonneville Power Administration (chair) and the Northwestern Division Engineer (member) of the U.S. Army Corps of Engineers .

Columbia River Treaty - United States Department of State

The Columbia River Treaty is a 1961 agreement between Canada and the United States on the development and operation of dams in the upper Columbia River basin for power and flood control benefits in both countries. Four dams were constructed under this treaty: three in British Columbia, Canada and one in Montana in the United States. The treaty provided for the sharing with Canada of half of the downstream US power and flood benefits, and allows the operation of Treaty storage for other benefits.
